



INTERNET PRIVACY POLICY STATEMENT

Welcome to the website of Nippon Wealth Limited ("NWB"). This section explains our policy regarding any personal information you might supply to us when you visit this site. NWB adopts a high standard to respect the privacy of its customers and keep the information relating to a customer secure and confidential. NWB also educates and conducts regular training programs to all staff to keep them aware of the importance of customers' privacy and requires them to comply with strict standards of security and confidentiality. Information may be collected on the use of web site from NWB's customers and NWB's web site visitors. If you do provide personal information, such as address, e-mail, telephone and fax numbers, as well as demographic and customer identification, please read our Notice to Customers and Other Individuals relating to Personal Data (Privacy) Ordinance (the "Notice"). We will maintain the personal information as well as your business activities and transactions, according to our usual strict security and confidentiality standard.

Data Collection and Usage

NWB collects personal data from NWB's website visitors on a voluntary basis. Personal information may include name, title, e-mail address etc. Personal information held by NWB is kept confidential and NWB does not use customers' personal information for any purposes other than those already specified to customers herein or in the Notice or unless such usage is permitted or required by law.

When an individual visits this website, NWB records the visit as a "hit", and gathers and analyses this information to compile general statistics about usage of NWB's website. Information related to session management, user preferences and service entitlements may be stored in Cookies. Cookies are small pieces of information stored on a web browser that can be retrieved by this website.

Data Disclosure Restrictions

NWB follows strict privacy procedures in regard to protection of personal data. No disclosure of personal identifiable information to third parties is allowed except with the consent of the relevant customer or the disclosure has already been authorized in the Notice or otherwise is permitted or required by law.

Data Retention

NWB retains all records of online transactions for validation and auditing purposes. Information will not be kept longer than is necessary for the fulfilment of the purpose

for which the same are to be used. Those information that is no longer required will be erased and destroyed.

Data Security

All personal data provided to NWB is secured with restricted access by authorized personnel who are properly trained in the handling of customer information and the protection of the privacy of personal data of customers. The authorized personnel report to NWB's Data Protection Officer who exercises routine supervision to ensure compliance with high security and confidentiality standard. Encryption technology is employed for sensitive data to protect customers' privacy during data transmission.
